**Delta.** Delta measures the rate of change of an option value with respect to changes in the underlying asset's price.

**The Bloomberg Commodity Index.** As of 2019, this widely used Index is made up of 23 exchange-traded futures contracts on physical commodities which are weighted within the Index to account for economic significance and market liquidity.
